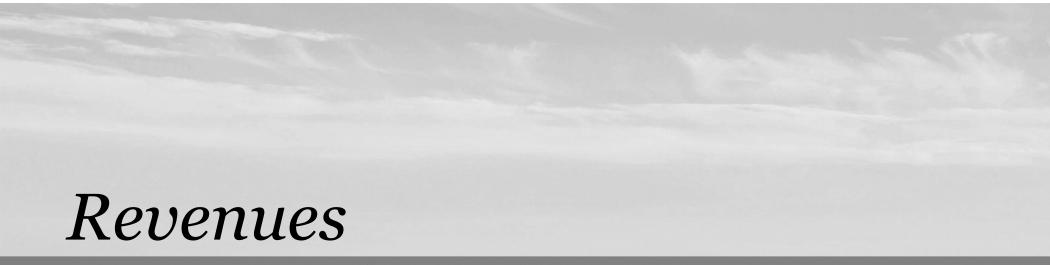

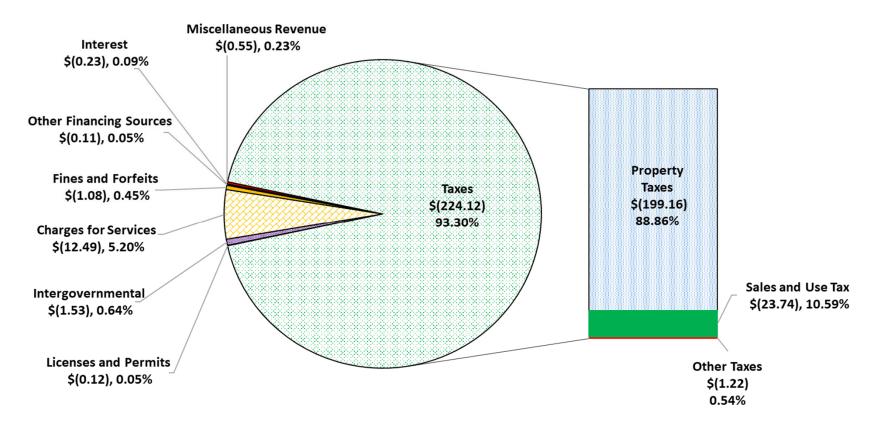

Amounts are in Millions



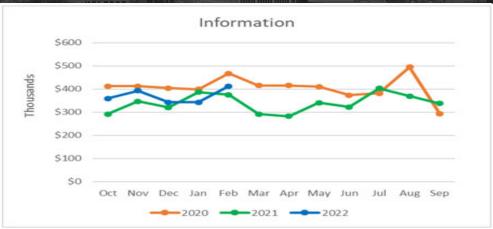

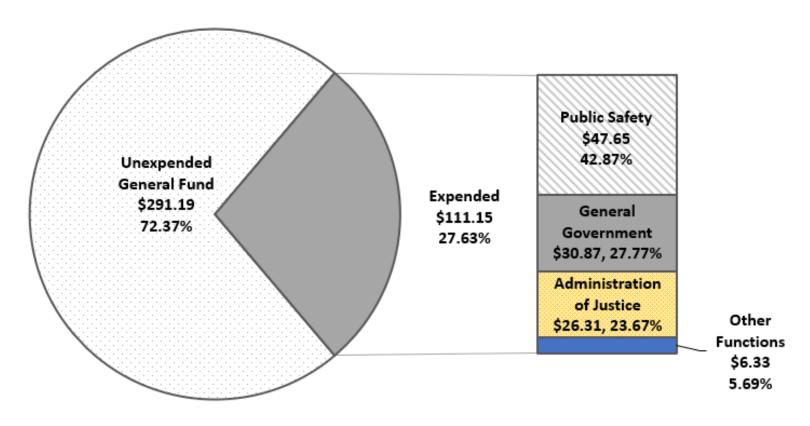

### Percentage of General Fund Expended YTD Fiscal Year 2022



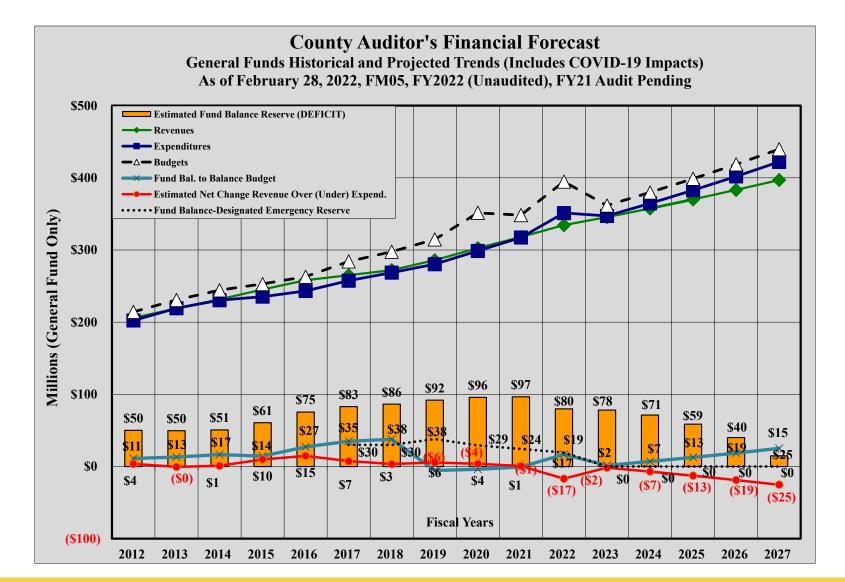
