PSYCHIATRIC EVALUATIONS AND SERVICES

This agreement is entered into by and between El Paso County on behalf of the Juvenile Probation Department, hereinafter known as "JPD" and El Paso Psychiatric Associates, P.A., d/b/a Alternatives Centre for Behavioral Health, hereinafter known as "Contractor".

1. SERVICES TO BE PERFORMED BY CONTRACTOR:

Contractor shall perform the following services for the JPD:

- 1.01 Contractor will provide services to address any psychiatric needs of the child along with the appropriate recommendation for treatment.
- 1.02 Contractor shall provide psychiatric diagnostic interview or examination to include the following: (1) patient's current status, (2) patient's history of present illness, (3) patient's medical history, (4) patient's drug/alcohol history, (5) developmental history, (6) patient's social history, (7) patient's legal history, (8) patient's mental status, (9) diagnostic impression and (10) prognosis and recommended disposition. Administrative expenses and communications with family, school or referral source are considered part of the cost and may not be invoiced as a separate cost. Interview or examination **must** include bio-psychosocial model, the use of rating scales and/or functional assessments for establishing a diagnosis, measuring social functioning levels and/or monitoring the changes in the severity of symptoms or side effects of psychotropic medications. Structured instruments utilized must be valid and reliable and account for cultural, gender and ethnic differences. Narrative Report must include a specific recommendation for treatment. As soon as a medication is prescribed, a written order (not verbal) should be provided with a prescription to include discontinuation of previously prescribed medication and a written order (not verbal) as to the dates and times that the prescribed medication should be administered. The psychiatrist and/or Clinical Nurse Specialist/Nurse Practitioner performing the evaluation MUST consult with the patient's attending psychiatrist for the purpose of correlating psychiatric treatment. Psychiatrist and/or Clinical Nurse Specialist/Nurse Practitioner must be able to conduct an evaluation in the language of literacy and understanding of the patient. Services pursuant to this agreement must be performed individually in a private session and directly by a psychiatrist with a license to practice in the State of Texas. An addendum to the original psychiatric evaluation may be requested for purposes of continuation of psychiatric services or upon exiting the juvenile justice system.
- 1.03 Contractor warrants 100% completion of all typed reports to include all reports submitted to JPD, within five (5) working days from date of referral for

psychiatric services, unless otherwise specified by court order of the 65th District Court. A typed copy of the psychiatric evaluation shall be provided to the Juvenile Probation Department whether they were paid through private insurance, CHIP or Medicaid, JPD, or any other source of funding. Contractor warrants said reports shall be responsive to the goals and outcome measures described in the Logic Model for Psychiatric Battery Evaluation. (Exhibit "A")

- 1.04 Contractor shall provide timely appointments at Contractor's facility between the hours of 8:00 a.m. 4:00 p.m., Monday Thursday. Alternatively, at a mutually agreed upon time by JPD and the Contractor, if services are to be provided at JPD.
- 1.05 On site testing is preferred for all juveniles detained. On site, juveniles may be available seven (7) days a week and Contractor must provide timely appointments, between 2:30 p.m. 3:30 p.m. or 4:00 p.m. 8:00 p.m. Monday Friday and Saturday Sunday from 8:30 a.m. 8:00 p.m.
- 1.06 Off site testing for juveniles who are detained, the interview with parents/guardian MUST be scheduled at the same times; parents and juvenile are to be secured in different locations to minimize safety and security concerns. Per the Texas Juvenile Probation Commission, a JPD employee will transport juveniles who are detained and the employee MUST be present within sight and sound of the juvenile at all times during the evaluation.
- 1.07 Contractor shall provide a written psychiatric evaluation identifying the diagnostic impression(s) of the patient to include all elements indentified in the psychiatric evaluation form noted in **Exhibit "B"**. Psychiatric Evaluations shall be provided to JPD within five (5) business days from date of evaluation to the assigned probation officer with a hardcopy to be mailed/hand-delivered to JPD's Accounting Unit within five (5) business days.
 - 1.07(1) Within 72 hours of referral from JPD, the Contractor shall schedule and evaluate the referred patient.
 - 1.07(2) Administrative expenses and communications with family, school, or referral source, or other agencies are considered part of the cost per evaluation and may not be billed as a separate cost.
 - 1.07(3) Costs include all typed and signed Psychiatric Evaluation to JPD.
 - 1.07(4) The Contractor shall bill a one-time fee for an evaluation performed regardless of the number of appointments needed to complete the evaluation. JPD will not be financially responsible for missed appointments. Contractor shall request a new Authorization of Service Contract for rescheduled appointments.
- 1.08 Upon authorization of the El Paso County Juvenile Probation Department and at

- 1.09 Contractor will provide a one (1) hour class, a minimum of four (4) times a year, in coordination with the El Paso County Juvenile Probation Department's Training Coordinator. Contractor will explain the evaluation process and the outcome of the psychiatric evaluations and/or mental disorders. Contractor shall explain how a diagnosis is determined and/or treatment practices.
- 1.10 Contractor shall submit claims on invoices bearing Contractor's letterhead not later than ten (10) working days from the last day of the month for which payment is requested to the El Paso County Juvenile Probation Accounting Department. Invoices not timely submitted shall not be paid. Letterhead shall contain an accurate mailing address and telephone number where Contractor can be reached during normal business hours. Contractor's invoice must indicate an invoice number, contract number KK-10-160, juvenile's and/or parent(s) name, type of service and related cost. Invoices for juvenile services must be submitted separately from parent services. Copy of the psychiatric evaluation and/or medical progress notes must be submitted with an invoice as supporting documentation to include provider's signature. If the evaluations and/or medical progress notes are not submitted with the invoice, payment will be delayed until documentation is provided to JPD. For individual sessions, Contractor shall provide the juvenile's name, type of service provided, and the related cost.
 - 1.10(1) Contractor shall establish procedures shall seek to and reimbursement and bill payment for covered services rendered pursuant to this agreement from any and all state/federal or other sources (such as Medicaid, CHIP, CHAMPUS or other public or private insurance), as applicable for eligible children in eligible settings. A covered service is a service for which reimbursement from either a public or private insurance plan is available. JPD shall be the payor of last resort. Contractor shall not bill JPD for any services rendered for which payment was received from any and all state/federal or other sources, as applicable. Contractor is required to accept the amount paid by any and all state/federal or other sources, as applicable, as payment in full. Invoices for services timely billed to, but denied by, other funding sources may be submitted to the County in accordance with the requirements of this agreement except that such invoices shall be submitted within 90 days from the date of service along with documentation of submission to and denial by the other funding source. In the event Contractor is later paid for the rendered service by any other funding source, Contractor shall reimburse all amounts to JPD for the rendered service within 30 days of receiving such payment. Contractor shall not supplement the contracted rate with Medicaid reimbursement or any other reimbursement. Invoices not timely

submitted shall not be paid.

1.10(2) Contractor shall submit through electronic notification (i.e. e-mail or fax) identified services and dates of service needed on a monthly basis. Based on information submitted by Contractor, JPD will generate an authorization of service contract. An authorization of service contract must be approved by JPD and received by the Contractor prior to services being rendered. Failure to do so will result in the Contractor absorbing the cost of services not approved. Contractor is required to designate an e-mail address or fax number of where the authorization of service contract must be submitted by JPD.

1.11 <u>Eligibility to Receive Payment on State Contracts.</u>

Under § 231.006, Texas Family Code, the Contractor certifies that the individual or business entity named in this agreement is not ineligible to receive the specified grant, loan or payment and acknowledges that this agreement may be terminated and payment may be withheld if this certificate is inaccurate.

- 1.12 Contractor shall permit the County to examine and evaluate Contractor's program of services provided under the terms of this agreement and to review client records. The examination and evaluation of the program will include unscheduled site visitations and observations of programs in operation. Contractor shall provide the County with evaluation data and information as requested for the purpose of completing performance evaluations of the program.
- 1.13 Contractor shall maintain separate accounting records designating receipt and expenditure of State Funds received pursuant to Paragraph 2 of this agreement. Contractor shall adhere to the use of Generally Accepted Accounting Principles (GAAP), promulgated by the American Institute of Certified Public Accountants (AICPA). Contractor understands that acceptance of funds under this agreement acts as acceptance of the authority of the State Auditor's Office, or any successor agency, to conduct an audit or investigation in connection with those funds. Contractor further agrees to cooperate fully with the State Auditor's Office, or any successor agency, to conduct an audit or investigation in connection with those funds. Contractor further agrees to cooperate fully with the State Auditor's Office or its successor in the conduct of the audit or investigation, including providing all records requested. Contractor will ensure that this clause concerning the authority to audit funds received indirectly by subcontractors through the Contractor and the requirement to cooperate is included in any subcontract it awards.
 - (1) Period Financial Reporting:
 Contractor shall provide semiannual, as well as, annual financial statements to include but are not limited to the following:

- a. Trial Balance, Balance Sheet, Profit and Loss Statement and Statement of Retained Earnings/Fund Balance certified by Contractor; or
- b. Independent Audit or Review (prepared in accordance with GAAP) based on Contractor's fiscal year. Contractor shall provide the County certified copies of the most recent documents of any, or all listed above, within 90 days from the Contractor's financial year-end.
- (2) Contractor certifies that the individual(s) or business entity named in this agreement is in good standing with the Texas Comptroller of Public Accounts.
- 1.14 Contractor shall maintain and make available for inspection, audit or reproduction, by an authorized representative of El Paso County or the State of Texas, Federal Government, books, documents and other evidence pertaining to the cost and expenses for this agreement, hereinafter called the Records.

1.14(1)Record Retention.

Contractor shall maintain financial and supporting documents, statistical records and any other records pertinent to the services for which a claim or expense report has been submitted. The records and comments must be kept for a minimum of four (4) years after the end of the contract period. If any litigation, claim, or audit involving these records commences before the three year period expires, the Contractor must keep records and documents for not less than three years or until all litigation, claims or audit findings are resolved, whichever is later.

- 1.15 Contractor shall ensure that within thirty (30) days of execution of this agreement all of its paid and unpaid personnel who are required or allowed to provide services pursuant to this agreement will
 - 1) submit their fingerprints through the Texas Department of Public Safety (DPS) Fingerprint Applicant Services of Texas (FAST) system for a criminal history search (Exhibit "D-1") and
 - 2) execute a Texas Law Enforcement Telecommunications System (TLETS)/National Crime Information Center (NCIC) records check (**Exhibits "D-2", "D-3" & "D-4"**) in order to allow the Juvenile Probation Department to perform the criminal records and Sex Offender background check as well Sex Offender Background search through the Texas Department of Public Safety.

1.16 Sanctions.

JPD shall conduct monitoring and evaluation of the performances of the Contractor or any subcontractor rendered pursuant to this agreement every six (6) months through use of the Private Service Provider Contractual monitors and Evaluation Report. (**Exhibit "E"**) JPD will notify the Contractor in writing of any deficiencies noted during such monitoring and may initiate the withholding suspension or reduction of payments as appropriate, based upon such monitoring.

- 1. As determined in the reasonable judgment of JPD, failure of Contractor to comply with any provisions of this agreement or a failure to achieve set goals and/or outcomes take appropriate corrective action in the event of violations may be considered a material breach of this agreement and may result in withholding, suspension, or reduction in payments or in immediate termination of this agreement as well as refund of payments. Contractor may be ineligible to receive future contracts.
- 2. Contractor warrants that it is certified, approved or licensed by all Federal, State, or local regulatory agencies or departments in compliance with all applicable regulatory agency or department policies, procedures and administrative rules to regulate any activity performed by the Contractor. Current proof of such certification, approval, license, registration or any other required regulatory permits shall be provided to the El Paso County Juvenile Probation Department within thirty (30) days of execution of this agreement.
- 3. Contractor shall disclose to El Paso County any pending or initiated criminal or governmental investigations within the last twelve (12) months preceding the execution of this agreement, as well as during the term of this agreement along with any results and/or findings related to the Contractor conducted by but not limited to the following agencies: Department of Justice, Texas Juvenile Probation Commission, Texas Department of Family and Protective Services or any other agency which may license or regulate the Contractor in the provision of these services.
- 1.17. Contractor shall provide JPD's Training Coordinator with written documentation within ninety (90) days of execution of this agreement, verifying receipt of mandatory training in the Texas Family Code §261.101 Persons Required to Report; Time to Report. This statutory provision requires certain persons to report child physical or mental health abuse or neglect. Contractor shall contact JPD Training Coordinator to request and arrange for the above training.
- 1.18 Contractor may be called upon to testify in a Court of Law; if so, Contractor shall cooperate fully.
- 1.19 Contractor shall ensure that all files and records generated or created pursuant to this agreement containing individually, identifiable health information in electronic, paper, and oral form also known as protected health information (PHI), is maintained and or disseminated in accordance with the Health

2. SERVICES TO BE PERFORMED BY THE JPD:

- 2.01 For and in consideration for the above stated services Contractor shall be paid a one-time fee of three hundred dollars (\$300.00) per initial Psychiatric Diagnostic Interview or Examination conducted by a licensed psychiatrist regardless of whether several appointments are needed to complete the initial Psychiatric Diagnostic Interview or Examination. For and in consideration for the above stated services Contractor shall be paid a one-time fee of three hundred and eighty-five dollars (\$385.00) per initial Psychiatric Diagnostic Interview or Examination conducted by a licensed psychiatrist for those juveniles detained at JPD and parents/guardians who are interviewed separately regardless of whether several appointments are needed to complete the initial Psychiatric Diagnostic Interview or Examination. For any Medication Follow-up visit, conducted by a licensed psychiatrist the rate will be one hundred dollars (\$100.00) per visit. A Contractor may be called to testify in Court of Law. Contractor shall be paid three hundred dollars (\$300.00) per hour in Court, when Contractor is called to testify as an expert by JPD. Contractor shall not be reimbursed if called to testify based on the need to substantiate a recommendation and/or to address errors or discrepancies in the report submitted or recommendation. All fees paid to Contractor pursuant to this paragraph include all typed documentation/reports to JPD. An addendum to the original psychiatric evaluation may be requested for purposes of continuation of psychiatric services upon exiting the juvenile justice system.
- For and in consideration for the above stated services Contractor shall be paid a one-time fee of two hundred dollars (\$ 205.00) per initial Psychiatric Diagnostic Interview or Examination conducted by a Clinical Nurse Specialist or Nurse Practitioner regardless of whether several appointments are needed to complete the initial Psychiatric Diagnostic Interview or Examination. For and in consideration for the above stated services Contractor shall be paid a one-time fee of two hundred and fifty dollars (\$250.00) per initial Psychiatric Diagnostic Interview or Examination conducted by a Clinical Nurse Specialist or Nurse Practitioner for those juveniles detained at JPD and parents/guardians who are interviewed separately regardless of whether several appointments are needed to complete the initial Psychiatric Diagnostic Interview or Examination. For any Medication Follow-up visit, conducted by a Clinical Nurse Specialist or Nurse Practitioner the rate will be one hundred dollars (\$100.00) per visit. A Clinical Nurse Specialist or Nurse Practitioner may be called to testify in Court of Law. Contractor shall be paid two hundred dollars (\$200.00) per hour in Court, when Contractor is called to testify as an expert by JPD. Contractor shall not be reimbursed if called to testify based on the need to substantiate a recommendation and/or to address errors or discrepancies in the report submitted or recommendation. All fees paid to Contractor pursuant to this paragraph include all typed documentation/reports to JPD. An addendum to the original psychiatric evaluation may be requested for purposes of continuation of

psychiatric services upon exiting the juvenile justice system.

- 2.03 Payment shall be made on invoices received pursuant to paragraph 1.10 within thirty (30) days of receipt by the El Paso County Juvenile Probation Department.
- 2.04 This Agreement is conditional upon, subject to and contingent upon receipt of adequate Federal and/or State funding to meet the liabilities of this Agreement. Contractor shall have no cause of action against JPD in the event JPD is unable to perform its obligations pursuant to this Agreement as a result of suspension, termination, withdrawal or failure of Federal and/or State funding to JPD.
- 2.05 JPD shall conduct monitoring and evaluation of the performances of the Contractor or any subcontractor rendered pursuant to this agreement pursuant to paragraph 1.16.

3. TERM AND TERMINATION:

Term:

This agreement shall be effective May 3, 2010, regardless of date of signatures, and shall continue until May 2, 2011. This agreement may be renewed for up to two (2) one year renewal options upon mutual written notice of the parties to this agreement prior to the expiration of the initial term or subsequent first renewal period.

Termination:

JPD and Contractor may mutually agree to terminate this Agreement at any time by giving 30 day written notice to terminate. Contractor may terminate this Agreement without cause by giving thirty (30) days written notice to terminate. JPD may terminate this Agreement without cause by giving thirty (30) days written notice to terminate. JPD may terminate this Agreement without notice immediately in the event Contractor fails to comply with any provision of this Agreement. Contractor shall cease to incur costs associated with this Agreement upon termination or receipt of written notice to terminate, whichever occurs first.

4. <u>INDEPENDENT CONTRACTOR:</u>

Nothing contained herein shall be construed as creating the relationship of employer and employee between the County and the Contractor. The Contractor shall be deemed at all times to be an independent contractor.

5. **ASSIGNMENT:**

Contractor shall not sell, assign, transfer or convey this agreement, in whole or in part, without the prior written consent of El Paso County.

6. <u>VENUE:</u>

This agreement will be governed and construed according to the laws of the State of Texas. This agreement is performable in El Paso County, Texas. Venue for any legal proceeding shall be in El Paso County, Texas.

7. **INDEMNIFICATION:**

- 7.01 Contractor shall defend, indemnify and hold harmless El Paso County, its officers, agents and employees from all claims or causes of action of any kind for injury or damage of any kind for injury or damage to any person or property brought by or on behalf of any person due to or related to the negligence or intentional act or omission of Contractor, its agents, employees, or subcontractors. Contractor shall pay any and all damages assessed against El Paso County, its officers, agents or employees of the El Paso County Juvenile Board, arising out of such negligence or intentional acts.
- 7.02 Contractor shall maintain at Contractor's own expense, Professional Malpractice Insurance with a policy limit of not less than \$1,000,000.00. Such policy shall be with an insurance company licensed to do business in Texas and shall be satisfactory to the County. All of said insurance policies shall name the County, its officers, employees of the El Paso County Juvenile Board as an additional insured and shall provide that the County shall be given at least thirty (30) days advance written notice of any lapse, amendment or cancellation.
- 7.03 Contractor shall purchase at its own expense, commercial public liability insurance in a general aggregate limit of not less than \$300,000.00 for each single occurrence for bodily injury or death and \$100,000.00 for each single occurrence for injury to or destruction of property. Policies shall be with an insurance company licensed to do business and shall be satisfactory to the County. All of said insurance policies shall name the County, its officers, employees and the El Paso County Juvenile Board as additional insured. El Paso County shall be given at least thirty (30) days advanced written notice of any lapse, amendment or cancellation.

8. **AGREEMENT:**

This document expresses the entire agreement between the parties and shall not be amended or modified except by written instrument signed by the parties.

9. **ENFORCEMENT**:

In the event that any portion of this Agreement shall be found to be invalid or unenforceable, the remaining terms and conditions shall be severed and shall remain in full force and effect.

10. NON-DISCRIMINATION AND EQUAL OPPORTUNITY:

Contractor certifies that it will comply fully with the non-discrimination and equal opportunity provisions of Title VII of the Civil Rights Act of 1964, as amended; section 504 of the Rehabilitation Act of 1973, as amended; the Age Discrimination Act of 1975, as amended; the Americans with Disabilities Act of 1990, as amended; and with all applicable requirements imposed by or pursuant to regulations that implement those laws.
