FIRST AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN THE HOUSING AUTHORITY OF THE CITY OF EL PASO AND THE COUNTY OF EL PASO ON BEHALF OF THE EL PASO COUNTY JUVENILE PROBATION DEPARTMENT

This Amendment is made to the interlocal agreement, by and between the Housing Authority of the City of El Paso ("HACEP"), a local government entity operating under Chapter 392 of the Texas Local Government Code, and the County of El Paso on behalf of the El Paso County Juvenile Probation Department ("JPD"), pursuant to the Interlocal Cooperation Act, Art. 791.001, et. Seq., Texas Government Code.

WHEREAS, Paragraph VI. of the original agreement provides that, "This Agreement may be modified only by written instrument signed by the parties."

NOW THEREFORE it is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed Agreement as follows:

I. Paragraph II of the Interlocal Agreement is amended to read as follows:

This Agreement shall be effective upon its execution and shall continue until May 3, 2011, and shall renew automatically for a one year period, and remain in effect subject to the Termination clause below.

II. Paragraph V, Subsection 1.(a.) of the Interlocal Agreement is amended to read as follows:

El Paso County Juvenile Probation Department will:

a. Serve approximately 210 youth and families that may receive services such as assessment and evaluation; substance abuse counseling and treatment; individual, group, and family counseling; anger management; parenting classes; multi-systemic therapy; cognitive skills training; community service learning; and community supervision by Probation Services, Field Compliance and Community Service units.

III. Paragraph V, Subsection 1.(c.) of the Interlocal Agreement is amended to read as follows:

El Paso County Juvenile Probation Department will:

c. Provide in-kind resources valued at \$378,000 over a three-year period. The in-kind resources will consist of community supervision by Probation Services; Field Compliance and Community Service units; assessment and evaluation; substance abuse counseling and treatment; individual, group and family counseling; anger management; parenting classes; multi-systemic therapy; cognitive skills training; and community service learning. Many of these children are charged with minor offenses such as truancy or running away from home. Others are considered serious offenders for committing crimes such as assault, burglary, and other felonies. Sanctions are progressive in nature as a means to balance public protection, offender accountability and rehabilitation. In most cases, the judge orders some form of probation supervision in the community or placement in a residential treatment facility.

IV. Paragraph V, Subsection 1.(e.) of the Interlocal Agreement is amended to read as follows:

El Paso County Juvenile Probation Department will:

d. Maintain proper documentation to track and report compliance and non-compliance with the community supervision and GED attainment. Progress reports and letter reporting the in-kind amount shall be provided to HACEP on a quarterly basis, along with financial receipts and/or documentation to support the in-kind match.

All other terms and conditions of the Agreement to remain in full force and effect.

INTERLOCAL AGREEMENT BETWEEN THE HOUSING AUTHORITY OF THE CITY OF EL PASO AND THE COUNTY OF EL PASO ON BEHALF OF THE EL PASO COUNTY JUVENILE PROBATION DEPARTMENT

This Interlocal Governmental Agreement is between the Housing Authority of the City of El Paso (HACEP), a local government entity operating under chapter 392 of the Texas Local Government Code, and the County of El Paso on behalf of the El Paso County Juvenile Probation Department (JPD), pursuant to the Interlocal Cooperation Act, Art. 791.001, et seq., Texas Government Code.

I. Purpose of Agreement

The purpose of this Agreement is to establish a cooperative and mutually beneficial relationship between the parties and to delineate the respective responsibilities of the parties as they relate to the 2008 Resident Opportunities and Self-Sufficiency (ROSS) Service Coordinators grant.

II. Duration of Agreement

This agreement shall be effective upon its execution and shall continue until February 28, 2011, and shall renew automatically thereafter on a year-to-year basis, for no more than two years, and remain in effect subject to the Termination clause below.

III. Parties Backgrounds

JPD judicially processes juvenile referrals between the ages of 10-16 years who have been referred by law enforcement and other agencies for alleged delinquent conduct.

HACEP provides quality, affordable, safe housing for low-income residents. Additionally, HACEP encourages self-sufficiency for its residents through direct services and through cooperative Agreements with agencies that provide training, education, and services that increase residents' opportunities for employment and self-sufficiency and that strengthen HACEP communities.

IV. General Provisions

It is understood by both parties that each will fulfill its responsibilities under this Agreement in accordance with the provisions of laws and regulations governing their activities. Nothing in this Agreement is intended to negate or otherwise render ineffective any such provisions or operating procedures. If at any time either party is unable to perform its functions under this Agreement consistent with each party's statutory and regulatory mandates, the affected party shall immediately provide written notice to the other to establish a date for mutual resolution of the conflict and/or termination of this Agreement.

- c. Provide in-kind resources valued at \$378,000 over a three-year period. The resources will consist primarily of community supervision by Probation Services, Field Compliance and Community Service units. Many of these children are charged with minor offenses such as truancy or running away from home. Others are considered serious offenders for committing crimes such as assault, burglary, and other felonies. Sanctions are progressive in nature as a means to balance public protection, offender accountability and rehabilitation. In most cases, the judge orders some form of probation supervision in the community or placement in a residential treatment facility.
- d. The overall success of the community supervision will consist of compliance with all the court-ordered rules so that the children leave JPD's care and custody. There are several rules that must be followed such as, but not limited to: school attendance, good conduct, staying within curfew, participating in specified programs and services, staying free of drug and alcohol usage, etc. A report will be provided to HACEP's Service Coordinators indicating compliance or non-compliance with the community supervision or at the residential treatment facility. In addition, the attainment of a GED will be considered a positive outcome.
 - e. Maintain proper documentation to track and report compliance and non-compliance with the community supervision and GED attainment. Progress reports and letter reporting the in-kind amount for the month shall be provided to HACEP on the 15th of each month for the previous month, along with financial receipts and/or documentation to support the in-kind match.

2. The Housing Authority of the City of El Paso will:

- a. Assign HACEP Service Coordinators to work collaboratively with the JPD community supervision staff in providing services to the youth and their families served through JPD.
- b. Provide facilities in the communities for JPD services to be performed, as needed.
- c. Actively recruit and encourage participation by families residing in HACEP properties.

3. HACEP and JPD will:

- a. Participate in joint planning for the aforementioned activities.
- b. Identify opportunities for collaboration, coordination and elimination of barriers regarding the services to be provided as part of this AGREEMENT.
- c. Maintain the confidentiality of youth' and families' information and use data only for the administration of the party's appropriate programs.
- d. Participate in monthly meetings for the initial six-months of the program and every two months thereafter.

VI. Modification. Assignment and Cancellation

This Agreement may be modified only by written instrument signed by the parties. The Agreement may not be assigned by either party in whole or in part. The Agreement may be cancelled by a party upon thirty (30) days written notice to the other party. If cancellation is for cause, it may be cancelled upon delivery of written notice to the other party.

VII. Independent Contractors

Nothing in this Agreement shall be construed to create an employer/employee or agency relationship or to allow either party the right to exercise control or direction over the employees or agents of the other party or the manner or method by which the other party provides the services under this Agreement.

VII. Notices
