Software License and Professional Services Agreement Change Order #3

This Change Order ("Change Order") to the Software License and Professional Services Agreement is entered into by and between Tyler Technologies, Inc., a Delaware corporation ("Software Provider"), and El Paso County (the "Purchaser"). This Change Order shall become effective as of the last date set forth on the signature page below (the "Effective Date").

Whereas, on June 25, 2010, Software Provider and the Purchaser entered into that certain Software License and Professional Services Agreement (the "Agreement") pursuant to which, among other things, Software Provider agreed to provide certain software licenses and professional services to the Purchaser; and

NOW, THEREFORE, in consideration of the mutual promises contained herein, along with other good and valuable consideration, the receipt and sufficiency of which both parties mutually acknowledge, the parties agree as follows:

1. A Tyler Consultant will conduct one (1) DPS citation importer workshop to educate El Paso departments (up to 16 participants). The workshop will include 3 full days onsite covering:
 - a. Training on how the DPS citation process works with Odyssey
 - b. Configuration consulting and assistance
 - c. End to end process testing with DPS
