## Water line extension Interlocal agreement with Lower Valley Water District

- APPROVED AS CORRECTED, INTERLOCAL AGREEMENT WITH LOWER VALLEY WATER DISTRICT FOR CONSTRUCTION AND MANAGEMENT OF WATERLINE FOR TORNILLO - GUADALUPE U.S. INTERNATIONAL PORT OF ENTRY AND INTERNATIONAL BRIDGE
- NOVEMBER 21, 2011 MOTION # 8 (Item # 34)
- On this day, on motion of Commissioner Gandara, seconded by Commissioner Haggerty, it is the order of the Court to approve the agenda item, as corrected, to authorize the County Judge to execute the Resolution [KK-11-482] authorizing construction and the Interlocal Agreement between Lower Valley Water District and the County [KK-10-421] for the construction and management of approximately 12 miles of waterline from Socorro to the Tornillo-Guadalupe Port of Entry. Funds are available in CPCAPITAL 07.

- Amount of Interlocal agreement is \$6,000,000.00

#### Sewer Line Installation

- Contract awarded to Red Cliff Inc., on March 22, 2012 in the amount of \$1,828,810.00.
- Contractor is working on site, but has fallen behind schedule and we are working with CEA (design engineer) and Red Cliff to get a recovery schedule to get the job completed.
