**The Purchasing Department received questions relating to the above referenced proposal; the response to the following question:**

- 1. In reviewing the RFQ for the Secure Border Trade Demonstration Project, I noticed that page 20 references Sections I & J within Attachment A. Comparing the language of Attachment A, there are no Sections I & J. The deliverables that were referenced to be included in Section I appear to be provided in Section H. However, I am more concerned about the language of the preliminary scope of work. Can you please send me any omitted portions of the RFQ document by reply email or via the below contact information.**

**Answer: Please note that page 20 of the RFQ references "Section F & J" within Attachment A. There is a Section F in Attachment A. It is titled F. Technical Approach, Work Plan and Implementation Schedule. You are correct, there is no Section J in Attachment A and that reference should have been H. Deliverables. At this time there is no other information concerning technical specifications that will be provided potential respondents. Following is an excerpt from page 20 that addresses the final technical specifications:**

**Final technical specifications will be provided to the short list respondent(s) emerging from this RFQ process. These technical specifications will comprise the County's concept for the SBT demonstration. Respondents are advised that if there are any descriptive inconsistencies in the scope of work discussed herein, the final technical specifications shall govern.**

- 2. In reviewing the Wage Rates on the County website there is reference to a Per Diem Wage Rate. Is this a daily or weekly rate?**

**Answer: Daily Rate**

- 3. Do the published Wage Rates apply to all public and private commercial construction projects in the County?**

**Answer: Yes**

- 4. Will system interface to external systems be in real-time, to a database or how will data be made available?**

**Answer: See answers provided in Addendum 1 – questions #9 and #11 dated March 22, 2010. The ultimate goal of the SBT will be to interface at least some system elements and data bases in real-time.**

- 5. Will the product of this contract be used in a day-to-day operational system?**

**Answer: Yes. We consider the SBT system that will be utilized during this demonstration to be an operating system.**

- 6. Please provide level of data security required.**

**Answer: Please review the answer to this question provided on March 22, 2020, in Addendum 1 – question #12.**

- 7. Will there be any classified or sensitive data that needs to be accessed?**

**Answer: Sensitive or secure data could come from government agencies, private sector trucking companies or maquilas. At this time we are not attempting to define all the data elements that will be required to operate the anticipated SBT system. When these data elements are defined and mutually agreed upon, we will work with the vendor and the data source organizations to see if data can be made available and under what conditions.**
