(This form must be signed by an officer, principal, or individual authorized to bind the company under a contract with the County.)

IN COMPLIANCE WITH CHAPTER 161 OF THE TEXAS LOCAL GOVERNMENT CODE, ANY VENDOR INVOLVED IN A SINGLE PROCUREMENT EXCEEDING \$50,000 MUST COMPLETE THE ENCLOSED ETHICS TRAINING BEFORE SUBMITTING A BID OR PROPOSAL WITH THE COUNTY OF EL PASO.

Purpose: The stability of democracy depends upon the continuing consent of the governed, which in turn depends upon the trust the electorate holds for its government. The Ethics Commission of the County of El Paso, Texas, in concert with elected county officials, as well as leaders of the various county departments, recognizes the need to maintain the public trust and confidence in the workings of county government and thus adopts this Code of Ethics.

What is a vendor:

Any person or their representative or employee whose goods and services are purchased under the terms of a purchase order or contractual agreement with the county; and any other persons doing business with the County.

Procurement: In advising upon, discussing, recommending, and/or granting any County purchases, bids or contracts, County public servants shall inform themselves about their financial interests, and shall make a reasonable effort to inform themselves about the financial interest of their family members.

County public servants shall excuse themselves from exercising influence, participating in, discussing, recommending, and/or granting of any County purchases, bids, or contracts if they or a family member have a substantial financial interest.

Private Communication: No member of the El Paso County Commissioners Court, County Elected Officials/Department Heads or the El Paso County Hospital District Board of Managers shall permit any vendor, its lobbyists, representative, or employee to communicate with him privately regarding any procurement of items by the County or the Hospital District from the date that the bid, RFP, or RFQ is authorized or released, whichever is first. No private communication regarding the purchase shall be permitted by a member of the Commissioners Court, a county elected official/department head, or

the hospital district board of managers until the procurement process is complete and a purchase order is granted or a contract is entered into.

Members of the Commissioners Court, county elected officials/department heads and the board of managers shall make a reasonable effort to inform themselves regarding procurements and shall have a duty to inquire of vendors, their lobbyists, representatives, or employees, the nature of the private communication being sought prior to engaging in any communication.

This prohibition against private communication with vendors, their lobbyists, representatives, or employees shall apply to commissioners court approval of hospital district purchases.

INTRODUCTION

The El Paso County Juvenile Probation Department “JPD” is seeking proposals from qualified individuals/companies to provide mental health evaluations of adolescents that have been placed with JPD. The County seeks to award a three (3) year contract, with the option to renew for an additional two-year term.

The County may award one or more contracts to qualified individuals or companies.

DEFINITIONS

- 1) “JPD” or “County” – The El Paso County Juvenile Probation Department, its employees, and other County employees that may be involved in conducting this procurement.
- 2) “Proposer” – The individual(s) or company responding to this Request For Proposal. Proposer shall include assigned staff of the company (the psychologist/psychological associate or clinician).
- 3) “Evaluation” – Either a biopsychosocial assessment evaluation conducted by a licensed clinician or a psychological evaluation conducted by a licensed psychologist or psychological associate.

MINIMUM QUALIFICATIONS:

Proposed staff shall be appropriately licensed in the State of Texas to perform the services listed in this RFP.

The Proposer warrants that it is certified, approved or licensed by all Federal, State or local agencies or departments that have jurisdiction to regulate any activity performed by the proposer. Proof of such certification, approval or license shall be provided to the El Paso County Juvenile Probation Department within ten (10) days of execution of an agreement.

SCOPE OF WORK

Purpose: To objectively assess and appraise youth referred to the El Paso County Juvenile Probation Department in order to obtain a comprehensive evaluation to identify if a child has a mental health disorder or other condition requiring therapeutic services and/or interventions. Approximately 150-200 youths will be evaluated per year.

Methods for Obtaining Information: The Proposer shall include, but will not be limited to, the following:

1. **Clinical Interview:** The psychologist/clinician shall include a face to face interview with the youth and the youth’s parent(s) / legal guardian(s). The clinical interview shall provide the psychologist/clinician with an indication of the youth’s interpersonal behaviors as well as emotional processes. The clinical interview shall include, but is not limited to, the following:

- a. Elicit information that might support or qualify a diagnosis as well as aid in the development of the treatment planning process.
 - b. Provide the psychologist/clinician with the opportunity to observe the youth's general style, how he/she may exaggerate or minimize information provided in the referral and/or youth's history, as well as identify how the youth communicates emotional issues and employs possible defense mechanisms.
 - c. The collection of useful information that will aid in the diagnosis and treatment of mental and/or behavioral health disorders. This collection should include, but not be limited to the following:
 - I. Medical information: serious illnesses, medical conditions and/or reported traumatic brain injuries the child may have sustained and if the child has ever sustained an injury to the head that led to a loss of consciousness, a concussion, or feeling "dazed," current and historical prescribed psychotropic medications.
 - II. Relevant Family History: current living arrangements in the home (ages, relationships), family history of drug use, involvement in the criminal justice system, strengths and weaknesses.
 - III. Referral History: juvenile probation referrals, out of home placements/programs.
 - IV. School History: current academic performance, attendance, discipline issues, special education services required.
 - V. Aggressive Behaviors: known incidents of violent/assaultive behaviors, including suicide ideations/attempts and self harm.
 - VI. Abuse/Neglect: known traumas, abuse, neglect, involvement in Texas Department of Family and Protective Services.
 - VII. Mental Health: known mental health treatment of youth and family members, dates of treatment, diagnoses, outcomes of treatment.
 - VIII. Developmental History: identification of any significant delays or missing of developmental milestones.
 - IX. Peer Associations and Social Engagements: nature of peer interactions and social activities.
 - X. Follow up regarding changes in cognitions, process speeds, behaviors, and/or emotional states shall be incorporated into the report
- 2. Collateral Sources:** Parent(s) / legal guardian(s), family members and/or other significant individuals in the youth's life shall be included in the clinical interview process. Collateral sources of information shall include, when available but not limited to: previous evaluations, reports, educational records and medical records. The child's strengths along with any noted areas of concern shall be identified and a recommendation for services shall be noted.
- 3. Full Battery Psychological Testing:** The use of structured instruments and standardized tests shall be used as components for establishing a diagnosis, as well as obtaining a comprehensive assessment for measuring the youth's

cognitive, behavioral, emotional and/or mental functioning levels. Structured instruments and rating scales must be valid and reliable to account for the youth's age, cultural, gender and ethnic differences. Psychometric testing is to be conducted for all evaluations and shall include, but is not limited to, the following:

- a. Individual Intelligence test (which specifies a Verbal IQ, a Performance IQ and a Composite, Single Full Scale IQ score);
- b. Organicity-perceptual tests;
- c. Psychopathology Checklist-Youth Version (PCL-YV) or comparable risk assessment (must identify risk factors that may lead to recidivism);
- d. Youth Self Inventory to include a depression inventory; anxiety, anger, disruptive behavior, and self-concept inventory;

Note: Evaluations must be conducted in the client's language of literacy. The evaluation must be performed in a private session directly by a psychologist/psychological associate or a mental health provider--An individual who is licensed or otherwise authorized to provide mental health services by one or more of the following licensing boards:

- (A) Texas State Board of Examiners of Psychologists;
- (B) Texas State Board of Examiners of Professional Counselors;
- (C) Texas State Board of Examiners of Marriage and Family Therapists;
- (D) Texas Department of State Health Services – Chemical Dependency Counselors Program;
- (E) Council on Sex Offender Treatment;
- (F) Texas Medical Board; or
- (G) Texas State Board of Social Worker Examiners. **A child psychologist is preferred.**

On site testing, 6400 Delta Dr. El Paso, Tx 79905, is preferred for detained youths. On site youths may be available seven (7) days a week and proposer must provide timely appointments between the hours of 2:30 p.m. to 3:30 p.m. or 4:00 p.m. to 8:00 p.m., Monday through Friday, and Saturday and Sunday from 8:30 a.m. to 8:00 p.m.

Off site testing, at the proposer's place of business, for detained youths must include an interview with the youth and his/her parent(s) / legal guardian(s) at separate times to minimize safety and security concerns. Per the Texas Juvenile Justice Department, a juvenile probation department employee will transport youth who are detained and the JPD employee **MUST** be present within sight and sound of the youth at all times during the evaluation.

APPOINTMENTS FOR EVALUATIONS

The Proposer shall schedule evaluations within ten (10) business days of referral by the Juvenile Probation Department. A typed, signed evaluation must be provided to the Juvenile Probation Department's Contract Coordinator within ten (10) business days from the date the evaluation is completed.

In the event, the juvenile is not seen on the scheduled appointment date due to Proposer oversight, the Proposer must provide the evaluation within ten (10) business days from the original scheduled appointment.

Should the juvenile and parent fail to attend their scheduled appointment, the Proposer shall contact the referring probation officer via email and the contract coordinator of the missed appointment within 24 hours of the missed appointment.

NARRATIVE REPORT: Upon completion of evaluation, the Proposer shall submit a typed, signed written report. The report shall follow a bio-psychosocial model to include detailed information about the youth's level of functioning across a wide range of contexts that are relevant to the disposition decision-making process. Evaluations shall include, but is not limited to, the following:

- a. a statement of the primary purpose of the assessment;
- b. a summary of the youth's background;
- c. list of procedures and tests used and a statement noting any limitations of the instruments used;
- d. summary of the results and recommendations relevant to the youth needs to include but not be limited to special services instructional modifications, behavioral management strategies, appropriateness for placement, and whether or not placement could include a physically oriented secure post-adjudication correctional facility;**
- e. diagnostic impression identifying any mental, emotional and/or behavioral health issues;
- f. separate verbal, performance and composite IQ scores must be included in the report;
- g. incorporate criminal and/or delinquent behaviors, history of substance abuse/dependence, risk factors, stressors, and strengths, as well as identify caregiver needs;
- h. assessment of the youth's cognitive abilities, emotional experiences, personality as well as offer insight regarding the severity of a particular disturbance and/or impairment and the capacity for adequate functioning; and
- i. serve as a reference tool for the determination and/or need for further testing, the development of a treatment plan, the youth's adaptability to various disposition environments and/or responsiveness to treatment and/or supervision recommendations;
- j. address specifically all areas identified in Section 1, Subsection C of the Clinical Interview listed above.

**Should the recommendation made by the assessing clinician recommend placement in the Challenge Academy (short-term or long-term) the following specific language shall be included in the report:

“First and Last Name is eligible for placement into a secure, post adjudication facility with a physically oriented behavior modification program. There are no physical or therapeutic contraindications to the resident’s participation in the physically oriented training program.”

The evaluation should provide the El Paso County Juvenile Probation Department and/or the Court with a structured, succinct and organized description of the referred youth’s current psychological functioning.

The Proposer may be called to testify in a court of law at no additional cost to El Paso County or the El Paso County Juvenile Probation Department to substantiate and/or clarify recommendations and/or diagnosis made.

The Proposer shall provide an addendum to the original evaluation completed within the previous year when requested for the purposes of continuation of services, and/or upon court request for clarification purposes.

The selected proposer will be required to attend state mandated training, Texas Family Code §261.101 *Persons Require to Report; Time to Report*. This code deals with reporting child physical or mental health abuse or neglect. Proposer shall provide proof of completion of mandated training, or if not shall attend training provided by the El Paso County Juvenile Probation Department.

The psychologist/ psychological associate or licensed clinician will explain the evaluation for the juvenile’s managing conservator in their language of literacy upon authorization of the El Paso County Juvenile Probation Department and at the request of the juvenile’s parent(s) / legal guardian(s);

COST PROPOSAL

Proposer’s Cost shall include the following:

- interview;
- mental health assessment;
- collateral contacts;
- diagnostic testing;
- assessments;
- addendum to the original evaluation;
- screening instruments;
- recommendations for services/interventions to address psychological diagnosis;
- administrative expenses (specified in detail);
- communications with family;
- communications with school;
- referral source (other agencies are considered part of the cost per evaluation)

- and may not be billed as a separate cost); and
- all typed and signed documentation/reports to the Juvenile Probation Department.

A. Provide a Cost Proposal per the following requirements:

- cost per evaluation conducted by a psychological associate;
- cost per evaluation conducted by a licensed psychologist;
- cost per Bio-Psychosocial evaluation conducted by a licensed clinician;
- cost per addendum on a psychological evaluation less than a year old conducted by a psychological associate
- cost per addendum on a psychological evaluation less than a year old conducted by a licensed psychologist
- cost per addendum on a Bio-Psychosocial assessment evaluation less than a year old conducted by a licensed clinician

The Proposer shall bill for all-inclusive services per the costs stated above and shall not bill for periodic appointments needed to complete the evaluation. In the event a juvenile misses a scheduled appointment with the proposer, the Juvenile Probation Department will not be responsible for paying any service fees to the proposer.

Evaluations shall not be handwritten. Evaluations shall be written using an electronic word processing software, dated and signed by the evaluator. The evaluation will be provided to the Juvenile Probation Department Contract Coordinator whether the proposer is paid through private insurance, CHIP or Medicaid, the Juvenile Probation Department, or any other source of funding.

All representations made by the Juvenile Probation Department are contingent upon availability of funds from which payments for contracted services can be made and do not represent an obligation on the part of the Juvenile Probation Department, the County of El Paso, the El Paso County Juvenile Board, or the Texas Juvenile Justice Department.

I. MEASUREMENT OF PROGRAM OUTCOME

Proposer will be responsible for submitting to the Juvenile Probation Department Contract Coordinator on a quarterly basis the following statistical data:

- comprehensive listing of juveniles referred for services to include:
 - juvenile's name, date of birth and docket number;
 - name of referring juvenile probation officer;
 - date(s) of service;
 - diagnosis made;
 - identification if service was provided in English or Spanish or other;
 - number of times and date(s) called to testify;
 - number of addendums requested.
 - Number of recommendations for removal or placement in a post adjudication secure facility

JPD STAFF TRAINING

The Proposer will provide a minimum of a 30 minute class twice (2) per year to El Paso County Juvenile Probation personnel in coordination with the El Paso County Juvenile Probation Department Contract Coordinator on the subject of explaining the evaluation process, outcomes of evaluations, mental health disorders, how a diagnosis is determined and/or treatment practices.

TERM OF CONTRACT

The services requested shall be provided for a period of three (3) years. The County shall have the option to renew any agreement entered into with the selected proposer for two (2) one year terms. Upon the same terms and conditions contained in its original agreement with the selected proposer by providing written notice to the proposer.

TERMINATION:

The County or the Proposer may terminate this Agreement at any time by giving thirty (30) days written notice, sent certified mail (Return Receipt Requested) to terminate. The County may terminate this agreement without notice immediately in the event Proposer fails to comply with any provision of this agreement. Proposer shall cease to incur costs associated with this agreement upon termination or receipt of written notice to terminate, whichever occurs first.

INSURANCE

Proposer shall comply with the Insurance Requirements as stated in the Provisions section of this RFP.

Proposer shall maintain at proposer's own expense, Professional Malpractice Insurance with a policy limit of not less than \$1,000,000.00. Such policy shall be with an insurance company licensed to do business in Texas and shall be satisfactory to the County. All of said insurance policies shall name the County and the El Paso County Juvenile Board, their officers, employees as additional insured and shall provide that the County shall be given at least thirty (30) days advance written notice of any lapse, amendment or cancellation. **A copy of the insurance certificate should be included in the bid package.**

BACKGROUND CHECKS

Proposer shall ensure that all of its paid and unpaid personnel who are required or allowed to provide services pursuant to any agreement entered into with the Juvenile Probation Department will execute a Texas Law Enforcement Telecommunications System (TLETS)/National Crime Information Center (NCIC) records check, in order to allow the Juvenile Probation Department to perform the criminal records check and Sex offender background check, as well as Sex Offender Background search through the Texas Department of Public Safety. Any costs associated with conducting this background check will be assumed by the selected proposer.

In addition, the Proposer shall require all of its paid and unpaid personnel who are required or allowed to provide services pursuant to this Agreement to submit their fingerprints through the Texas Department of Public Safety (DPS) Fingerprint Applicant Services of Texas (FAST) system for a criminal history search. Proposer is responsible for the fee associated with the search.

LEGAL REQUIREMENTS

Any agreement entered into between the selected proposer and the Juvenile Probation Department shall not be that of an employer and employee. The selected proposer shall be deemed at all times to be an independent contractor.

The selected proposer shall not sell, assign, transfer or convey any agreement entered into with the Juvenile Probation Department, in whole or in part, without the prior written consent of Juvenile Probation Department.

Any agreement entered into between the selected proposer and the Juvenile Probation Department will be governed and construed according to the laws of the State of Texas and will be performable in El Paso County, Texas. Venue for any legal proceedings shall be in El Paso County, Texas.

Any agreement with a selected proposer is conditional upon, subject to and contingent upon receipt of adequate Federal and/or State funding. The selected proposer shall have no cause of action against the Juvenile Probation Department in the event the Juvenile Probation Department is unable to perform its obligations as a result of suspension, termination withdrawal or failure of Federal and/or State funding to the Juvenile Probation Department.

Any agreement entered into between the parties shall not be amended or modified except by written instrument signed by the parties. In the event that any portion of an agreement shall be found to be invalid or unenforceable, the remaining terms and conditions shall be severed and shall remain in full force and effect.

Any selected proposer must certify that it will comply fully with the non-discrimination and equal opportunity provisions of Title VII of the Civil Rights Act of 1964, as amended; section 504 of the Rehabilitation Act of 1973, as amended; the Age Discrimination Act of 1975, as amended; the Americans with Disabilities Act of 1990, as amended; and with all applicable requirements imposed by or pursuant to regulations that implement those laws.

All representations made by the Juvenile Probation Department are contingent upon availability of funds from which payments for the contract services can be made and do not represent an obligation on the part of the Juvenile Probation Department, the County of El Paso, or the Texas Juvenile Justice Department.

Proposer shall disclose to El Paso County any pending or initiated criminal or governmental investigations within the last twelve- (12) months preceding the execution of this agreement, as well as during the term of this agreement along with any results and/or finding related to the proposer conducted by but not limited to the following agencies: Department of Justice, Texas Juvenile Justice Department, Texas Department

of Family and Protective Services or any other agency which may license or regulate the Proposer in the provision of these services.

Proposer shall ensure that all files and records generated or created, pursuant to this contract containing individually, identifiable health information in electronic, paper and oral form also known as protected health information (PHI) is maintained and/or disseminated in accordance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and Chapter 58 of the Texas Family Code.

The signer of the proposal must declare that all persons, companies or parties interested in the contract as principals are named therein; that the proposal is made without collusion with any other person, persons, company or parties submitting a proposal; that it is in all respects fair and in good faith without collusion or fraud; and that the signer of the proposal has authority to contractually bind the proposer.

FINANCIAL INFORMATION

A Juvenile Probation Department employee will generate an authorization of service contract which identifies services to be provided, date and time of scheduled appointments.

An authorization of service contract must be approved by the Juvenile Probation Department and received by the contractor prior to services being rendered. Failure to do so will result in the proposer absorbing the cost for services not approved. Proposer is required to designate an e-mail address or fax number of where the authorization of service contract must be submitted by the Juvenile Probation Department.

The selected proposer will be required to establish procedures, seek reimbursement and bill payment for covered services rendered pursuant to any agreement entered into with the Juvenile Probation Department from any and all state/federal or other sources (such as Medicaid, CHIP, Tricare, CHAMPUS or other public or private insurance), as applicable for eligible children in eligible settings. A covered service is a service for which reimbursement from either a public or private insurance plan is available. The Juvenile Probation Department shall be the payer of last resort. Proposer shall not bill the Juvenile Probation Department for any services rendered for which payment was received from any and all state/federal or other sources, as applicable. Proposer is required to accept the amount paid by any and all state/federal or other sources, as applicable, as payment in full. Invoices for services timely billed to, but denied by, other funding sources may be submitted to the Juvenile Probation Department. The invoices shall be submitted within ninety (90) days from the date of service along with documentation of submission and denial by the other funding source. In the event proposer is later paid for the rendered service by any other funding source, proposer shall reimburse all amounts to the Juvenile Probation Department within thirty (30) days of receiving such payment. Proposer shall not supplement the contracted rate with Medicaid reimbursement or any other reimbursement. Invoices not timely submitted shall not be paid.

Proposer shall submit claims on invoices bearing proposer's letterhead no later than ten (10) working days from the last day of the month for which payment is requested to the El Paso County Juvenile Probation Accounting Department. Letterhead shall contain an

accurate mailing address and telephone number where proposer can be reached during normal business hours. Proposer's invoice must indicate an invoice number and contract number, juvenile's and/or parent(s) / legal guardian(s) names, type of service and related cost. Invoices for juvenile's services must be submitted separately from parent's services. If supporting documentation is not submitted, payment will be delayed until evaluation and/or addendums are provided to the Juvenile Probation Department Contract Coordinator. Invoices not timely submitted shall not be paid.

The Juvenile Probation Department receives an invoice from the proposer. The department will verify the services performed by the proposer through the department's authorization of service contract. The department will then process the invoice for payment through the County Auditor's Office within thirty (30) days of receipt. The County Auditor's Office will generate a check and mail to the proposer after Commissioner's Court approval. Payment for services with state funds will be identified on the check with a note "TJJD STATE FUNDS".

Proposer shall maintain separate accounting records designating receipt and expenditure of all state funds received. Proposer shall adhere to the use of Generally Accepted Accounting Principles (GAAP), promulgated by the American Institute of Certified Public Accountants (AICPA.) Proposer understands that acceptance of funds acts as acceptance of the authority of the State Auditor's Office, or any successor agency, to conduct an audit or investigation in connection with those funds. Proposer further agrees to cooperate fully with the State Auditor's Office or its successor in the conduct of the audit or investigation, including providing all records requested. Proposer will ensure that this clause concerning the authority to audit funds received indirectly by sub proposers through the proposer and the requirement to cooperate is required to be included in any subcontract it awards.

Proposer must maintain and make available for inspection, audit or reproduction, by an authorized representative of El Paso County or the State of Texas, Federal Government, books, documents and other evidence pertaining to the cost and expenses for any agreement entered into with the Juvenile Probation Department.

Proposer shall provide semi-annual, as well as, annual financial statements to include but are not limited to the following:

- Trial Balance, Balance Sheet, Profit and Loss Statement, and Statement of Retained Earnings/Fund Balance certified by proposer; or
- Independent Audit or Review (prepared in accordance with GAAP) based on proposer's fiscal year. Proposer shall provide the County certified copies of the most recent documents of any, or all listed above, within 90 days from the proposer's financial year-end.

Proposer will be required to certify that the individual(s) or business entity named in any agreement entered into with the Juvenile Probation Department is in good standing with the Texas Comptroller of Public Accounts.

Under §231.006, Texas Family Code, the proposer certifies that the individual or business entity named in any agreement entered into with the Juvenile Probation Department is not ineligible to receive the specified grant, loan or payment and acknowledges that any

agreement entered into with the Juvenile Probation Department may be terminated and payment may be withheld if this certificate is inaccurate.

Proposer shall maintain financial and supporting documents, statistical records and any other records pertinent to the services for which a claim or expense report has been submitted. The records and comments must be kept for a minimum of seven (7) years after the end of the contracted period. If any litigation, claim or audit involving these records commences before the seven (7) year period expires, the proposer must keep records and documents for not less than seven (7) years or until all litigation, claims or audit findings are resolved; whichever is later.

SANCTIONS

Every six (6) months, the Juvenile Probation Department will conduct monitoring and evaluation of the performances of the proposer or any sub proposer rendered pursuant to the contract through use of the Private Proposer Contractual Monitors and Evaluation Report. Juvenile Probation Department will notify the proposer in writing of any deficiencies noted during such monitoring and may initiate the withholding, suspension or reduction of payments as appropriate, based upon such monitoring.

As determined in the reasonable judgment of the Juvenile Probation Department, failure of proposer to comply with any provisions of this agreement or a failure to achieve set goals and/or outcomes, or failure of the proposer to properly administer subcontracts and take appropriate corrective action in the event of violations by sub proposers, may be considered a material breach of this contract and may result in withholding, suspension, or reduction in payments or in immediate termination of this agreement as well as refund of payments. Proposer may be ineligible to receive future contracts.

PROPOSAL SUBMISSION

The Proposer shall submit one (1) original and three (3) electronic version of the complete proposal (CD/DVD/Flashdrive) in PDF format. Proposals must be received by the El Paso County Purchasing Department at the address indicated on the cover page of this RFP no later than **July 28, 2016 at 2:00 p.m.** Mountain Daylight Savings Time. A representative at the Purchasing Department will date-stamp and time-stamp every proposal received immediately upon receipt. All proposals received before the proposal submission deadline will be kept in a secure location at until the due date and time.

PROPOSAL FORMAT

The applicant's original proposal must be unbound with no staples or heavy paper stock within the document itself. It may be necessary to reproduce the original application to provide sufficient copies for review purposes. Therefore, the applicant should not include anything that cannot be photocopied using automatic processors. Such items include anything stapled, folded, pasted, or in a size other than 8 ½" x 11" on white paper and heavy or lightweight paper which could disable the photocopy machine and/or become destroyed. Odd sized attachments of any kind will not be copied or sent to reviewers. Excessive or over-sized material, e.g., posters, videotapes, or audiotapes should not be

included. Documents may be photo-reduced or have type closer than 15 characters per inch. Furthermore, only one side of each page should have printing.

Application materials could accidentally get out of order when being processed, thus every sheet of the proposal must have a page number. It is also requested that pages be numbered consecutively from beginning to end (for example, page 1 for the Cover Page, page 2 for Letter of Transmittal, page 3 for the Table of Contents, etc.). Any appendices should be labeled and separated from the narrative and budget section, and the page numbers should be continued in the sequence.

Within each section of the proposal, applicants should address the items in the order in which they appear in the RFP. Any proposal that does not adhere to this format, and which does not address each specification and requirement within the RFP may be deemed non-responsive and rejected on that basis. B. LETTER OF TRANSMITTAL

A Letter of Transmittal must accompany each proposal and must be signed by the individual authorized to bind the company in any contract with the Juvenile Probation Department.

The Letter of Transmittal must:

- Identify the applicant organization and contact person;
- Identify the name and title of the person authorized by the organization to contractually obligate the organization;
- Identify the legal status of the submitting organization (proprietorship, corporation, non/for-profit, etc.).
- Include federal tax number
- Identify the name, title, telephone and FAX number of the person to be contacted for clarification;
- Explicitly indicate acceptance of all requirements of the RFP;

1. be signed by the person authorized to contractually obligate the organization;
2. acknowledge receipt of any and all amendments to this RFP;
3. must be on official business letterhead.

C. TABLE OF CONTENTS

Immediately following the letter of transmittal, the applicant is required to provide a table of contents that identifies all subsequent sections and pages.

D. PROPOSAL NARRATIVE

A cost per Bio-Psychosocial assessment evaluation conducted by a licensed clinician must be submitted to include all requirements under section A - **Cost Proposal** on page 4 of this RFP.

A cost per addendum conducted by a psychological associate must be submitted to include all requirements under section A - **Cost Proposal** on page 4 of this RFP.

A cost per addendum conducted by a licensed psychologist must be submitted to include all requirements under section A - **Cost Proposal** on page 4 of this RFP.

A cost per addendum on a Bio-Psychosocial evaluation must be submitted to include all requirements under section A - **Cost Proposal** on page 4 of this RFP.

PROPOSAL EVALUATION

A representative from the El Paso County Purchasing Department will open the proposals immediately after the deadline and will record them. A representative for the El Paso

County Juvenile Probation Department will perform a preliminary review of the proposals to determine compliance with the mandatory requirements of the RFP. The County Evaluation Committee will review all proposals and evaluate each according to the evaluation criteria. The contents of any proposal shall be kept confidential during the evaluation process.

All proposals received by the El Paso County Purchasing Department on or before the submission deadline shall become the property of the El Paso County Juvenile Probation Department and shall not be returned to the applicant. The El Paso County Juvenile Probation Department shall have the right to use any or all ideas contained in the proposal. Acceptance or rejection of a proposal shall not affect this right.

General Provisions County of El Paso, Texas

These General Provisions are considered standard language for all County of El Paso BIDS and Request for Proposal documents. If any “specific bid requirements” differ from the General Provisions listed here, the “specific bid requirements” shall prevail.

1. BID/PROPOSAL PACKAGE

- a. The request for bid/proposal, general and special provisions, drawings, specifications/line item details, contract documents and the bid/proposal sheet are all considered part of the bid/proposal package. Bids/Proposals must be submitted on the forms provided by the County, including the bid/proposal sheet completed in its entirety and signed by an authorized representative by original signature. Failure to complete and sign the bid/proposal sheet/contract page (s) may disqualify the bid/proposal from being considered by Commissioners’ Court. Any individual signing on behalf of the proposer expressly affirms that he or she is duly authorized to tender this bid/proposal and to sign the bid/proposal sheet/contract under the terms and conditions in this bid/proposal. Proposer further understands that the signing of the contract shall be of no effect unless subsequently awarded and the contract properly executed by Commissioners’ Court. All figures must be written in ink or typed. Figures written in pencil or with erasures are not acceptable. However, mistakes may be crossed out, corrections inserted, and initialed in ink by the individual signing the bid/proposal. Changes must also be made to any electronic copies submitted. If there are discrepancies between unit prices quoted and extensions, the unit price will prevail. Each bidder/proposer is required to thoroughly review this entire bid/proposal packet to familiarize themselves with the bid/proposal procedures, the plans and specifications for the requested work as well as the terms, and conditions of the contract the successful proposer will execute with the County.
- b. Bid/Proposal must be in the Purchasing Department BEFORE the hour and date specified. Faxed or e-mailed bids/proposals will not be accepted. Late bids/proposals will not be considered under any circumstances.**
- c. Any bid/proposal sent via express mail or overnight delivery must have the BID/RFP number and title clearly marked on the outside of the envelope or package. Failure to clearly identify your bid/proposal may be cause for disqualification.

2. COMPETITIVENESS AND INTEGRITY

To prevent biased evaluations and to preserve the competitiveness and integrity of such acquisition efforts, proposers are to direct all communications regarding this bid/proposal to the El Paso County Purchasing Agent or assigned designee, unless otherwise specifically noted.

An authorized person from the submitting firm must sign all bids/proposals. The signature acknowledges that the proposer has read the bid/proposal documents thoroughly before submitting a bid/proposal and will fulfill the obligations in accordance to the terms, conditions, and specifications.

Please carefully review this Request for Bid/Proposal. It provides specific information necessary to aid participating firms in formulating a thorough response.

3. BIDDERS'S/PROPOSER'S RESPONSIBILITY

The Bidder/Proposer must affirmatively demonstrate its responsibility. The Bidder/Proposer must also meet the following minimum requirements:

- Have been in business of providing services for a minimum of one (1) years;
- Have adequate financial resources or the ability to obtain such resources as required;
- Be able to comply with all federal, state, and local laws, rules, regulations, ordinances and orders regarding this Request for Bid/Proposal;
- Have satisfactory record of performance;
- Have a satisfactory record of integrity and ethics; and
- Be otherwise qualified and eligible to receive an award.

4. REJECTION OF BIDS/PROPOSALS

The County, acting through its Commissioners' Court reserves the right to: (1) reject any and all bids/proposals and waive any informality in the bids/proposals received; (2) disregard the bid/proposal of any proposer determined to be not responsible. The County further reserves the right to reject any bid/proposal due to failure of performance on deliveries as determined in writing by the County Purchasing Agent.

5. RESTRICTIVE OR AMBIGUOUS SPECIFICATIONS

It is the responsibility of the prospective proposer to review the entire invitation to bid/proposal packet and to notify the Purchasing Department if the specifications are formulated in a manner that would restrict competition or appear ambiguous. Any such protest or question(s) regarding the specifications or bid/proposal procedures must be received in the Purchasing Department no less than seventy-two hours prior to the time set for bid/proposal opening. Vendors are to propose as specified herein or propose an approved equal. The mention of any brand name in the specifications is not intended to be restrictive, but is intended to describe the general features and requirements (or equivalent) that the County of El Paso is seeking.

Under Local Gov't Code Section 262.005 and Health & Safety Code Section 361.426, the County is required to give preference to products made of recycled materials if they meet specs. The County is also required to encourage the use of recycled products in developing new procedures and specs. They are also required to eliminate procedures and specifications that explicitly discriminate against products made of recycled materials.

6. SUBSTITUTES

It is not the County's intent to discriminate against any material of equal merit to those specified however, should the proposer desire to use any substitutions, prior written approval shall be obtained from the County Purchasing Agent sufficiently in advance in order that an addendum might be issued.

7. EXCEPTIONS TO BID/PROPOSAL

The proposer will list on a separate sheet of paper any exceptions to the conditions of the bid/proposal. This sheet will be labeled, "Exceptions to Bid/Proposal Conditions", and will be attached to the bid/proposal. If no exceptions are stated, it will be

understood that all general and specific conditions will be complied with, without exception.

The Bidder/Proposer must specify in its bid/proposal any alternatives it wishes to propose for consideration by the County. Each alternative should be sufficiently described and labeled within the bid/proposal and should indicate its possible or actual advantage to the program being offered.

The County reserved the right to offer these alternatives to other proposers.

8. PRICING

Bid/Proposals for equipment shall offer new (unused) equipment or merchandise unless otherwise specified. Quotes F.O.B. destination. If otherwise, show exact cost to deliver (merchandise only). Bid/Proposal will be either lump sum or unit prices as shown on the bid/proposal sheet. The net price will be delivered to the El Paso County, including all freight or shipping charges. In case of error in extension, unit prices shall govern. BID/RFP subject to unlimited price increases will not be accepted. The County is tax exempt and no taxes should be included in your bid/proposal.

Unless prices and all information requested are complete, bid/proposal may be disregarded and given no consideration.

In case of default by the contractor, the County may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the contractor, the difference between the price named in the contract of purchase order and the actual cost thereof to the County. Prices paid by the County shall be considered the prevailing market price at the time such purchase is made. Periods or performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the Purchasing Agent and the Commissioners' Court.

9. TAX EXEMPTION

Pursuant to Section 151.309 of the Texas Tax Code, El Paso County qualifies for exemption from sales, excise and use taxes imposed under the Limited Sales, Excise, and Use Tax Act, which is codified at Chapter 151 of the Texas Tax Code. In accordance with Section 151.309, a taxable item sold, leased, or rented to, or stored, used, or consumed by the County is exempt from the taxes imposed under Chapter 151.

10. MODIFICATION OF BIDS/PROPOSALS

A bidder/proposer may modify a bid/proposal by letter at any time prior to the submission deadline for receipt of bids/proposals. Modification requests must be received prior to the submission deadline. Modifications made before opening time must be initialed by bidder/proposer guaranteeing authenticity. Bids/Proposals may not be amended or altered after the official opening with the single exception that any product literature and/or supporting data required by the actual specifications, if any, will be accepted at any time prior to the Commissioners' Court consideration of same. No substitutions or cancellations for merchandise will be permitted without written approval of the County Purchasing Agent.

11. SIGNATURE OF BIDS/PROPOSALS

Each bid/proposal shall give the complete mailing address of the Bidder/Proposer and be signed by an authorized representative by original signature with the authorized representative's name and legal title typed below the signature line. Each bid/proposal shall include the Bidder's/Proposer's Federal Employer Identification Number (FEIN), failure to sign the Contract page(s) and bid/proposal response sheet will disqualify the bid/proposal from being considered by the County. The person signing on behalf of the Bidder/Proposer expressly affirms that the person is duly authorized to render the bid/proposal and to sign the bid/proposal sheets and contract under the terms and conditions of this BID/RFP and to bind the Bidder/Proposer thereto and further understands that the signing of the contract shall be of no effect until it is properly placed on the Commissioner's Court agenda, approved in open Court, authorized to be executed by the County Judge, and fully executed by both parties.

12. AWARD OF BID/PROPOSALS-EVALUTATION CRITERIA AND FACTORS

Pursuant to the Texas Local Government Code

Bids shall be awarded to the responsible bidder that submits the lowest and best bid.

Bid/Proposals will be made to the responsible proposer whose bid/proposal is determined to be the best evaluated offer demonstrating the best ability to fulfill the requirements set forth in this Request for Bid/Proposal. The prices proposed will be considered firm and cannot be altered after the submission deadline. **The proposed cost to the County will be considered firm, unless the County invokes its right to request a best and final offer and cannot be altered after the submission deadline.**

The County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this BID/RFP and may discontinue its efforts under this BID/RFP for any reason or no reason or solely for the County's convenience at any time prior to actual execution of the contract by the County. County reserves the right to accept or reject all or any part of the bid/proposal, waive minor technicalities, or to award by item or by total bid/proposal. Price should be itemized.

A Bidder/Proposer whose bid/proposal does not meet the mandatory requirements set forth in this BID/RFP will be considered noncompliant.

Each Bidder/Proposer, by submitting a bid/proposal, agrees that if its bid/proposal is accepted by the Commissioners' Court, such Bidder/Proposer will furnish all items and services upon the terms and conditions in this BID/RFP and contract.

Contractor shall submit to the County, for approval, within ten (10) days from notice of contract award, all Certificates of Insurance evidencing the required coverage as described under Insurance in the schedule of the Requests for Bids/Proposals.

13. PUBLIC INFORMATION ACT

The parties agree that the County is a governmental body for purposes of the Public Information Act, codified as Chapter 552 of the Texas Government Code and as such is required to release information in accordance with the Public Information Act. Bidder/Proposer agrees that it has marked any information that it considers to be confidential, proprietary, and/or trade secret in its bid/proposal. County agrees to provide notice to Bidder/Proposer in accordance with the Public Information Act in the

event the County receives a request for information under the Public Information Act for information that the Proposer has marked as confidential, proprietary, and/or trade secret.

14. RESULTANT CONTRACT

The resultant contract shall become effective upon the Commissioners' Court execution of the same. The contract documents shall consist of the contract, the general and special provisions, the drawings, bid/proposal package, any addenda issued, and any change orders issued during the work.

The criteria utilized for determining responsibility of bidder/proposer(s) includes, but is not limited to, the proposer's experience, skill, ability, business judgment, financial capacity, integrity, honesty, possession of the necessary facilities or equipment, previous performance, reputation, promptness, and any other factor deemed relevant by the County to determine whether a bidder/proposer is responsible. The term of the resultant contract will begin as stated in the contract executed by the Commissioners' Court and will terminate on the date specified in the contract unless terminated earlier as herein set forth.

15. ESTIMATED QUANTITIES

Any reference to quantities shown in the Request for Bids/Proposals are an estimate only. Since the exact quantities cannot be predetermined, the County reserves the right to adjust quantities as deemed necessary to meet its requirements.

16. CONTRACTOR INVESTIGATION

Before submitting a bid/proposal, each contractor shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and to verify any representations made by the County upon which the contractor will rely. If the contractor receives an award as a result of its bid/proposal submission, failure to have made such investigations and examinations will in no way relieve the contractor from its obligation to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the contractor for additional compensation.

17. NO COMMITMENT BY COUNTY

This Request for Bid/Proposal does not commit the County to award any costs or pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a bid/proposal to this request, or to procure or contract for services or supplies.

18. BEST AND FINAL OFFERS

In acceptance proposals, the County reserves the right to negotiate further with one or more of the contractors as to any features of their proposals and to accept modifications of the work and price when such action will be in the best interest of the County. This includes solicitations of a Best and Final Offer from one or more of the proposers. If invoked, it allows acceptable proposers the opportunity to amend, change or supplement their original proposal. Proposers may be contacted in writing requesting that they

submit their best and final offer. Any such best and final offer must include discussed and negotiated changes.

19. SINGLE BID/PROPOSAL RESPONSE

If only one (1) bid/proposal is received in response to the Request for Bids/Proposals, a detailed cost bid/proposal may be requested of the single contractor. A cost/price analysis and evaluation and/or audit may be performed of the cost bid/proposal in order to determine if the price is fair and reasonable.

20. REJECTION/DISQUALIFICATION OF BIDS/PROPOSALS

El Paso County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this bid/proposal package and may discontinue its efforts for any reason under this bid/proposal package at any time prior to actual execution of the Contract by the County. Bidders/Proposers may be disqualified and rejection of bid/proposals may be recommended to the Commissioners' Court for any of (but not limited to) the following causes:

- A. Failure to use the bid/proposal form(s) furnished by the County, if applicable.
- B. Lack of signature by an authorized representative that can legally bind the company on the bid/proposal form.
- C. Failure to properly complete the bid/proposal.
- D. Bids/proposals that do not meet the mandatory requirements.
- E. Evidence of collusion among bidders/proposers.

21. CHANGES IN SPECIFICATIONS

If it becomes necessary to revise any part of this bid/proposal, a written notice of such revision will be posted on the County Purchasing website. The County is not bound by any oral representations, clarifications, or changes made in the written specifications by the County's employees, unless such clarification or change is posted on the County Purchasing website. It shall be Bidder's/Proposer's responsibility to check the website prior to the bid/proposal opening date to verify whether any addendums have been posted.

22. BID/PROPOSAL IDEAS AND CONCEPTS

The County reserves the right to adopt or use for its benefits, any concept, plan, or idea contained in any bid/proposal.

23. BID/PROPOSAL DISCLOSURES

Results of bids/proposals for the purchase of goods, materials, general services and construction are considered public information at the time of the bid/proposal opening. All information contained in the bid/proposal response is available for public review.

The Proposal for Services: Only the names of those who submitted proposals will be made public information until an award is made by Commissioners' Court and contract executed by the parties. No price, staffing or other proposal information will be released. Proposers are requested to withhold all inquiries regarding their proposal or other submissions until after an award is made. No communication is to be had with any County employee, other than the Purchasing Agent, regarding whether a proposal was received. Violations of this provision may result in the rejection of a proposal.

24. WITHDRAWAL OF BID/PROPOSAL

Bidders/Proposers may request withdrawal of a sealed bid/proposal prior to the scheduled bid/proposal opening time provided the request for withdrawal is submitted to the Purchasing Agent in writing. No bids/proposals may be withdrawn for a period of sixty (60) calendar days after opening of the bids/proposals.

25. INDEMNIFICATION

- A. If Contractor fails to do so, then the County reserves the right to pay unpaid bills of which County has written notice direct and withhold from Contractor's unpaid compensations a sum of money reasonably sufficient to liquidate any and all such lawful claims.

The County shall have the unfettered right to monitor and audit the Vendor's work in every respect. Local Government Code § 176.001(1-a): "Business relationship" means a connection between two or more parties based on commercial activity of one of the parties. The term does not include a connection based on:

- (A) a transaction that is subject to rate or fee regulation by a federal, state, or local governmental entity or an agency of a federal, state, or local governmental entity;
- (B) a transaction conducted at a price and subject to terms available to the public; or
- (C) a purchase or lease of goods or services from a person that is chartered by a state or federal agency and that is subject to regular examination by, and reporting to, that agency.

Local Government Code § 176.003(a)(2)(A) and (B):

(a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:

(2) the vendor:

(A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, other than investment income, that exceeds \$2,500 during the 12-month period preceding the date that the officer becomes aware that

- (i) a contract between the local governmental entity and vendor has been executed;
- or
- (ii) the local governmental entity is considering entering into a contract with the vendor;

(B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:

- (i) a contract between the local governmental entity and vendor has been executed; or
- (ii) the local governmental entity is considering entering into a contract with the vendor.

Local Government Code § 176.006(a) and (a-1)

(a) A vendor shall file a completed conflict of interest questionnaire if the vendor has a business relationship with a local governmental entity and:

- (1) has an employment or other business relationship with a local government officer of that local governmental entity, or a family member of the officer, described by Section 176.003(a)(2)(A);
- (2) has given a local government officer of that local governmental entity, or a family member of the officer, one or more gifts with the aggregate value specified by Section 176.003(a)(2)(B), excluding any gift described by Section 176.003(a-1); or
- (3) has a family relationship with a local government officer of that local governmental entity.

(a-1) The completed conflict of interest questionnaire must be filed with the appropriate records administrator not later than the seventh business day after the later of:

(1) the date that the vendor:

- (A) begins discussions or negotiations to enter into a contract with the local governmental entity; or
- (B) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential contract with the local governmental entity; or

(2) the date the vendor becomes aware:

- (A) of an employment or other business relationship with a local government officer, or a family member of the officer, described by Subsection (a);
- (B) that the vendor has given one or more gifts described by Subsection (a); or
- (C) of a family relationship with a local government officer.
