The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for County of El Paso, Texas from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that County of El Paso, Texas may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that County of El Paso, Texas is proposing to increase property taxes for the 2024 tax year.

# No-New-Revenue Tax Rate Adjustments

#### State Criminal Justice Mandate (For Counties)

The County of El Paso, Texas County Auditor certifies that El Paso County has spent \$ 2,821,447 (minus any amount received from state revenue for such costs) in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. El Paso County Sheriff has provided information on these costs, minus the state revenues received for reimbursement of such costs.

This increased the no-new-revenue maintenance and operations rate by \$0.0029/\$100.

# Indigent Health Care Compensation Expenditures (counties)

The County of El Paso, Texas spent \$16,292,278 from July 1, 2023 to June 30, 2024 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$1,437,385. This increased the no-new-revenue maintenance and operations rate by \$0.002174 /\$100.

# **Indigent Defense Compensation Expenditures (counties)**

The County of El Paso, Texas spent \$15,223,108 from July 1, 2023 to June 30, 2024 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under article 26.05, Code of Criminal Procedure, and to fund operations of a public defender's office under article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year's enhanced indigent compensation expenditures is \$1,526,540.

This increased the no-new-revenue maintenance and operations rate by \$0.001036/\$100.
