CONTRACT REFERENCE NO: <u>2012-0298</u> (IF APPLICABLE):

SUBJECT: Approve and authorize the County Judge to sign Change Order No. 001 for \$14,040.00 that enables the County to reflect necessary changes to its Fixed Price Construction Contract between Owner and Contractor with Sunlight Enterprises Co., Inc. (K11-367) signed September 12, 2011 and reflects the final contract cost of \$498,355.00 and a substantial completion date of August 1, 2012.

BACKGROUND/DISCUSSION OF TOPIC:

Commissioners Court authorized the expenditure of capital improvement funds to refresh various facilities in Ascarate Park. Bid No. 11-024 was to renovate the Ascarate Park Pavilion. This structure returned to the County after the termination of the Western Playland lease. The renovation included the opportunity to make the facility year around asset for the Park. The contractor added new accessible restrooms and upgraded the building and surrounding area. The Fixed Price contract allowed for the replacement of purlins, part of the roof infrastructure. The contractor and architect identified two for replacement. Once construction began, the architect recommende changes based on field conditions to the water source for the facility. Park staff also accepted a recommendation to add a counter to the preparation area so that users of the facility could lay out food for their guests. The architect also recommended the addition of a small stage for the Pavilion, which would be useful for entertainment. There was additional work to repair concrete around the building and fencing changes around the structure. The architect rolled the credits and the additional charges into one Change Order at the conclusion of the project. The only remaining issue is the installation of a new fire hydrant at the request of the Fire Department. Staff is working with El Paso Water Utilities to facilitate that effort. The installation of the fire hydrant has delayed substantial completion and this Change Order reflects a new date for substantial completion.

FISCAL IMPACT:

This adds \$14,040.00 to the contract cost and funds are available in CPASCPKIM07.

PRIOR COMMISSIONERS COURT ACTION (IF ANY):

Commissioners Court approved the award to Sunlight Enterprises on August 15, 2011. Commissioners Court approved the Fixed Price Construction contract on September 12, 2011.

RECOMMENDATION: The Department recommends approval of this item.
