## RESOLUTION

WHEREAS, El Paso County Commissioners Court supports the construction of the new Manuel F. Aguilera Road, from SH 20 to IH10 in El Paso County; and

WHEREAS, the Commissioners' Court recognizes that the Texas Transportation Commission extended the original terminus of Manuel F. Aguilera Road, designated as Farm to Market Road 3380, a distance of approximately 0.6 miles southwestward of SH 20 from its original terminus at SH 20 pursuant to Minute Number 113031 dated February 23, 2012; and

WHEREAS, El Paso County Commissioners Court has determined that Minute Order 113031 contains an error which needs to be corrected in that it overstates the distance by which the southernmost terminus of Farm to Market Road 3380 (FM 3380) should be located; and

WHEREAS, El Paso County Commissioners Court requests that the actual and corrected southernmost terminus of Farm to Market Road 3380 (FM 3380) should be extended from its original terminus at SH 20 southwestward to a new terminus south of El Paso in the Tornillo Community, a distance of approximately 0.36 miles; and

WHEREAS, El Paso County Commissioners Court finds that correcting and shortening the designation of FM3380 will facilitate the flow of traffic, promote public safety, and maintain continuity of the state highway system and is necessary for the proper development and operation of the Texas transportation system;

NOW, THEREFORE, BE IT RESOLVED, that the El Paso County Commissioners Court supports the correction of the southernmost terminus of Farm to Market Road 3380 to a distance of approximately 0.36 miles southwestward of SH 20.
