Said repairs and replacements must be accomplished to the satisfaction of the Obligee by the expiration date of this Maintenance Bond. At the County's discretion, the expiration date may be extended to accommodate the accomplishment of these repairs. Failure to complete the repairs within the required time shall be considered a condition of default under this bond.

**NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH** that, The Obligee after final acceptance of the work, and after acceptance by the Commissioner's Court of the said property will provide a letter to the Principal along with the original Maintenance Bond identifying full and complete acceptance of the said property.
